



Ionization and Controls Standard Warranty

This constitutes iAIRE, LLC's sole warranty and obligation with regard to our products as well as the Customer's sole remedy.

iAIRE, LLC expressly disclaims all liability and responsibility for any special, indirect or consequential damages or any further loss of any kind whatsoever resulting from the use of our product. The Customer's sole and exclusive remedy and the limit of iAIRE, LLC's liability for any loss whatsoever, shall not exceed the purchase price paid by the Customer for the product to which a claim is made.

3. This warranty is limited to the original Customer only. It cannot be transferred or assigned to third parties unless the intent to transfer to a third party is expressly indicated in a purchase order and/or warranty processing arrangements have been agreed upon in writing by iAIRE, LLC.
4. An appropriate charge (maximum of 50% of invoiced price) will be made for testing, repairs, replacement and shipping for returned product which is not defective or found to be defective as the result of improper use, maintenance or neglect.

Under no circumstances does iAIRE, LLC agree to pay for labor or other related expenses associated with the troubleshooting and/or repair of our product without prior specific written authorization.
